- 3. Brief Description of Works The Work Involves Upgrading of Lodoare Gate Golini road (83Km) and access road of Olduvai Museum (5Km) From Gravel to Hardened standard
- 4. The Ngorongoro Conservation Area Authority (NCAA) Arusha Region intends to pre-qualify Civil works contractors registered with Contractors Registration Board (CRB); or capable of being registered in Class I for carrying out under mentioned works for the works for upgrading Lodoare Gate Golini road 83Km and 5Km access road of Olduvai Museum to hardened standard. It is expected that invitations to tender shall be made in *February*, 2019
